Annual Report: Roger Allen presented the report, which had been previously circulated. In addition to those mentioned in the Report, Roger thanked Roger Ashley for towing the GER trailer and Sue Fray, Gill Allen and Rachel Allen for their catering arrangements at Pratts Bottom.

Treasurer's Report: Jeff Fray presented the report, which had been previously circulated in unaudited form and advised they it had now been audited. Glenn Allen was thanked for carrying out the Audit. A loss was sustained with expenses exceeding income as only one event was held. For that event at Pratts Bottom an invoice for hall hire was awaited. Roger Allen thanked Jeff for his work as Treasurer

Roger Allen noted that Andrew had been a member of the committee since its inception in 2005 and had been instrumental in its formation. He had been the first Chairman and latterly membership secretary. Roger thanked Andrew for his contribution and noted that Andrew was prepared to continue maintaining the Group membership record. It was very pleasing to record that three new nominations to join the committee had been received from David Groves, Wayne Evans-Addy and John Dean. Existing committee members Roger Allen, Jeff Fray, Martin Piper and John Morgan were content to continue. It was proposed by Roy Lloyd and seconded by Andrew Lloyd that these seven individuals be elected en-bloc, which was agreed. Roger Allen said he would arrange the next committee meeting in March
